

## CHAPTER- 6

### FEE STRUCTURE (PER ANNUM)

The candidates, at the time of reporting to the colleges for confirmation of admission in B.Ed.-2 Years and B.A. B.Ed.-4 Years (Regular) Programmes for the session 2025-26, are required to deposit Fee as per following Fee Structure:

1. Govt./Govt. Aided College(s) of Education: Rs. 18,160/- + (University Charges)
2. Self-Financing College(s) of Education : Rs. 44,000/- + (University Charges)

The Annual University Charges prescribed by Guru Jambheshwar University of Science and Technology, Hisar from for the session 2025-26 are as under:

10.	Maintenance Charges (per student per annum)	150/-	

**Note:**

1. All the University shares, i.e. Fee/ Charges mentioned against each head except the share of affiliated college wherever mentioned, will be deposited in the University account at the time of online submission of Registration Returns/Continuation in respect of admitted students.
2. **Eligibility Fee:** This fees will be charged from the foreign students only to obtain the eligibility certificate from the University before considering his/her admission.
3. The above fee is subject to revision by University or the State Government from time to time.
4. If a candidate having admitted in a programme as per Seat Allocation List of 1st Counselling gets selected in other college in subsequent counselling or college level physical counselling notified by the

University, then she/he is entitled to take refund of her/his fee without any deduction, on the same day of her/his written request, from the previous college. The candidate shall apply for refund of fee in the previous college up to 12:00 Noon on working day, if she/he wants refund on the same day of request.

5. In case, a candidate after having deposited required fee for admission to a programme for session 2025-26 decides to leave the said programme before the last round of counselling, the fee deposited by the candidate will be refundable to him/her by the concerned college, if the seat so vacated is filled by some other candidate after deducting Rs. 1000/- only. However, the guidelines of the UGC/State Govt./University from time to time regarding refund of fee will also be applicable.
